DATA MANAGEMENT INFORMATION OF THE III. VISEGRÁD 4 COMPETITION CONFERENCE

As the organiser of the III. Visegrad 4 Competition Conference, the Hungarian Competition Authority (GVH) processes personal data related to participation at the Conference. Considering Article 13 of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation; hereinafter GDPR), the GVH provides the following information:

1. General information

The GVH will organise the III. Visegrad 4 Competition Conference on 27 April 2022 (hereinafter referred to as "the Conference") taking into account the global health situation in a hybrid way, both in person and online. The Conference will take place in the Multifunctional Hall of the Várkert Bazár. After registering, online participants will be able to connect to the Zoom platform via a link sent by the GVH (hereinafter: Platform), where they can follow the Conference events and participate in its presentations.

The participant will receive a link indicating that the registration was successful, and information on the fact that online participants will receive a link to join via e-mail at a later date. The Platform will be available only for the duration of the Conference, on 27 April 2022.

The III. Visegrad 4 Competition Conference is a public event. On the one hand, the GVH will provide the press with access to the Conference programme during the Conference, on the other hand, it will make available information and presentations from the Conference, including crowd scenes and photographs of speakers later.

The GVH hereby informs the parties concerned that it may grant permission to third parties (the press) to make recordings at the Conference, however, in such cases, the GVH will not process personal data, a third party who processes the personal data of the data subject in accordance with its own privacy notice is considered to be an independent data controller.

Only crowd shots can be made of persons attending the Conference who aren't panel members, moderators or keynote speakers. These crowd shots will be processed by the GVH for publication on its website, Facebook and LinkedIn pages and in the Parliamentary Report. Comments on agenda items may be made orally or in writing, as instructed by the moderators.

These will be read out to the speakers by the participant in the case of face-to-face participation or by the moderator in the case of online participation, depending on the circumstances.

Information on the data processing in this context is set out in the table in section 4.3 of this notice. The Data Processor also takes mass photographs of the persons attending the Conference.

6. Data transmission

In addition to the processors indicated in point 5, the GVH may carry out the following potential data transfers.

On the basis of a legal mandate, various bodies and authorities may apply to the GVH for information, data or documents. The GVH discloses to various bodies or authorities the amount of personal data strictly necessary to achieve the purpose of the request, provided that the exact purpose and scope of the data are specified.

Furthermore, the GVH hereby informs you that the uploading of pictures of panel members, moderators and keynote speakers on LinkedIn and Facebook constitutes a transfer of personal data to a third country, considering that the services of these social networking sites require the flow of data from the European Union to the United States and back. The transfer of personal data to third countries by Meta Platform Ireland Limited and LinkedIn Ireland Unlimited is based on Commission Implementing Decision (EU) 2021/914¹, to which the standard contractual clauses set out in the Annex apply.

The GVH shall not transfer your personal information to any international organization.

7. Security of processing

The GVH shall implement appropriate logical, physical and administrative measureses to ensure a level of security that is appropriate to the risks that are presented by personal data processing, especially unauthorised access, alteration, unauthorized disclosure, publication, deletion or destruction and accidental destruction or damage.

8. Rights of the data subject

8.1. Right of access by the data subject

You shall have the right to obtain confirmation through the contact details provided in points 2 and 3 or through the contact details of the colleagues responsible for organising the Conference as to which personal data the GVH processes, on what legal basis, for what purpose, since when and for how long. You will gain access to the following information:

- how the GVH obtained your personal data, if the data was not collected from you;

- to whom, when and under what law the GVH has given access to your personal data, or to whom, when and under what law the GVH transmitted them;
- to find out if the personal data concerning you has been rectified, erased or limited by the GVH and to object to the processing of personal data;
- you can turn to the National Authority for Data Protection and Freedom of Information or to the competent court, with the remedies detailed in point 9

The GVH will comply with your request within 1 month at the latest, using the contact details available to it or any other contact details you provide in your request.

8.2. Right to rectification

You may request that inaccurate personal data concerning you be corrected by the GVH, stating the reasons for the request, using the contact details provided in points 2 or 3 or by contacting the staff responsible for organising the Conference. The GVH will comply with your request without undue delay and will inform you using the contact details available or any other contact details you provide in your request. The GVH shall inform those to whom the personal data have been disclosed of the rectification of personal data, unless this is impossible or involves a disproportionate effort. At your request, the GVH will provide information on these recipients.

8.3. Right to erasure

The GVH will delete your personal data as specified in each case of processing. Even before this date, the GVH shall have the obligation to erase personal data if you withdraw your consent. The GVH will also delete your personal data at your request, if:

- their treatment is unlawful, or
- the personal data are no longer necessary for the purposes for which they were collected or otherwise processed by the GVH, or
- you object to the processing as described in point 8.5, or
- they must be deleted in order to comply with a legal obligation under EU or Member State law applicable to the GVH.

You may not exercise your right to erasure in respect of the data contained in row 2 of the table in point 4.2 and in point 4.4 of this privacy policy, because the processing of the personal data referred to here is necessary for the performance of tasks carried out by the GVH in the exercise of its official authority.

The GVH shall inform those to whom the personal data have been disclosed of the erasure of personal data, unless this is impossible or involves a disproportionate effort. At your request, the GVH will provide information on these recipients.

8.4. Right to restriction of processing

You shall have the right to contact the GVH via the contact details provided in points 2 and 3 or via the contact details of the staff responsible for organising the Conference and to obtain from the GVH restriction of processing where one of the following applies:

- the accuracy of the personal data is contested by you, for a period enabling the GVH to verify the accuracy of the personal data;
- the processing is unlawful, and you oppose the erasure of the personal data and request the restriction of their use instead;
- the GVH no longer needs the personal data for the purposes of the processing, but they are required by you for the establishment, exercise or defence of legal claims;
- you have objected to the processing

Where processing has been restricted, such personal data shall, with the exception of storage, only be processed with your consent or for the establishment, exercise or defence of legal claims or for the protection of the rights of another natural or legal person or for reasons of important public interest of the EU or of a Member State. If you have obtained restriction of processing, you shall be informed by the GVH before the restriction of processing is lifted.

The GVH shall communicate any restriction of processing to each recipient to whom the personal data have been disclosed, unless this proves impossible or involves disproportionate effort. The GVH shall upon your request inform you about those recipients.

8.5. Right to object

You shall have the right to object through the contact details provided in points 2 and 3 or through the contact details of the colleagues responsible for organising the Conference, against the processing of the personal data in line 2 of the table in point 4.2 and in point 4.4.

In this case, the GVH may no longer process the personal data, unless the processing is justified by compelling legitimate grounds which override the interests, rights and freedoms of the applicant or are related to the establishment, exercise or defence of legal claims. If you believe that the GVH would use your personal data for direct marketing or public opinion polling purposes, you may also object to the processing of your personal data, unless the processing is necessary for the performance of a task carried out for reasons of public interest.

8.6. Right to data portability

You may request, using the contact details provided in points 2 or 3 or the contact details of the colleagues responsible for organising the Conference, that your personal data in row 1 of the table in points 4.1 or 4.2 of this privacy policy be sent to you by the GVH in a structured, commonly used, machine-readable format. The GVH is also entitled to transmit these data to another data controller.

8.7. Right to withdraw consent

If you are attending the Conference as a participant, you can give your consent by ticking the box. If you are attending the Conference as a panel member, moderator or keynote speaker, you can give your consent by completing a consent form. You may withdraw your consent at any time by contacting the contact details provided in points 2 or 3 or by contacting the colleagues responsible for organising the Conference. Withdrawal of consent shall not affect the lawfulness of processing based on consent prior to its withdrawal.

9. Enforcement options regarding the processing of personal data

If you feel that the GVH has violated the applicable data protection requirements, you have the right to make a declaration to the National Authority for Data Protection and Freedom of Information and request an inquiry.

In order to ensure the protection of your personal data, you also have the possibility to appear in front of a court, which will rule on the matter out of turn. If you are not a Hungarian resident or domiciled in Hungary, you may bring your action before the Budapest Capital Regional Court, which is the competent court for the seat of the GVH.

10. Other provisions

The GVH reserves the right to unilaterally amend this privacy notice, subject to prior notification to the data subjects via the GVH website.

This privacy notice is effective from 26 April 2022.
