On 28 October 2010, the commitments proposed by Google became binding: the content policy of its AdWords service concerning databases for GPS navigation devices for motor vehicles has to be implemented in an objective, transparent and non discriminatory manner.

### **Hungary: Cartel on the Grain Market**

On 28 October 2010, the Hungarian Competition Authority imposed fines totalling HUF 2 300 000 000 (approx. € 8 400 000) on 16 milling companies for their participation in a price-fixing and market sharing cartel.

### **Italy: Binding Commitments by Consorzio Bancomat and Italian Banking Association**

Following the decisions of the Italian Competition Authority of 30 September 2010, reductions in bank charges for Pagobancomat, Bancomat and the set-up of direct debit (RID) and electronic payment instrument (RiBa) services have been implemented.

### **Slovakia: Supreme Court upheld Competition Authority's Decision in Cargo Railway Case**

On 26 October 2010, the Supreme Court of the Slovak Republic upheld the decision of the Antimonopoly Office of the Slovak Republic of 22 December 2006 in an abuse case. The European Commission had intervened as Amicus Curiae on the application of the concept of economic continuity within an undertaking and the effectiveness of fines in relation thereto.

The aim of these standards is to ensure that expert economic opinions which are submitted to the authority for assessing the facts of a case under competition law satisfy minimum quality requirements.
